

## OPEN ARENA RULES

#### **FAIRGROUND RULES**

- Anyone not on horseback must be outside the dirt arena.
- No horses on the concrete apron.
- Children 17 and under are considered 'Youth' and must be supervised by an adult.
- No alcoholic beverages are allowed during Open Ride.
- No riding or behavior lessons/clinics/training (commercial or other) are allowed during Open Ride.
- Proper riding etiquette must be followed at all times.
- Any equipment used such as barrels, etc. must be returned after their use.
- Riders are responsible for cleanup of their horses. Manure both in the Community Indoor Arena and outside the building on the Fairgrounds should be placed in the proper receptacles.
- Everyone must have a waiver on file to ride. Please sign forms at the arena desk.
- Participation in Open Arena without a signed waiver on file releases the County & DCTR of any and all responsibility.
- All riders both Youth and Adult must sign in before riding.
- DCTR & Douglas County is not responsible for accidents or injuries to horses or individuals, theft, loss, or damage to personal property.

#### **ADDITIONAL DCTR RULES**

- \$10 Temp Memberships can only be purchased 3 times and then guests must purchase a DCTR membership.
- 3 horse Limit per rider, additional horses will be \$5 extra per horse. This applies to members & non-members.
- Youth riders must wear a helmet & proper boots.
- Jumping activities require a helmet and proper equipment.
- No bareback, riding double, unless DCTR rep approves.
- If you run your horse please alert others in the arena, get an
   OK from others so no one is caught off guard.
- Any equipment used should not take up more than 1/2 the arena, and 1/2 left open for riders. Any equipment set up can be used by anyone.
- Be courteous and understand it's a shared arena space, be mindful of others and don't be afraid to speak up if you see dangerous or disruptive behavior.
- If any rider is asked to leave for inappropriate behavior, they must file an appeal to DCTR before returning.
